# **PATROL:**

#### **ADDITIONAL INFORMATION:**

The police department received 1797 calls for service from 07/01/23 – 07/31/23. 31 Adults and Juveniles were either arrested or summoned into court for various charges to include: Assault & Battery on a Police Officer, B&E Building Nighttime for Felony, Operating Under the Influence of Drugs, Indecent Exposure, Leave Scene of Property Damage Accident and Violate Abuse Prevention Order. There were twenty nine (29) Motor Vehicle Accidents investigated, 6 of the accidents resulted in personal injury. 14 People were taken to the hospital for a Mental Health Evaluation. Officers responded to complaints that resulted in 46 Incident Reports being created for various crimes.

- Officer Tom DeJordy and Officer Dan Deveau (Uxbridge Police) held the first of two Youth Police Academies.
- Chief Labrie and Lieutenant Ouillette attended a joint meeting with the command staff of the Fire Department and DPW (Department of Public Works) to plan the annual fireworks.
- Under the direction of Lt. Ouillette, several Officers of the department provided traffic control security, and crowd control at the annual fireworks held on July 15th
- Sgt. Brian Patrinelli provided a Defensive Tactics class to the Millville Police Department.
- Chief Labrie hosted the monthly meeting of the Northbridge Safety Committee.
- Officer Ryan Falvey attended a day camp class at the Whitin Community Center to speak with the children about various safety topics.
- Chief Labrie and DPW Director Luchini met with a representative of OWL Services to discuss the plan to replace the underground gas tank at the police department.
- The two (2) new police motorcycles were sent to Sunshine Sign Co. for lettering. After the lettering, they will be sent to MHQ in Marlboro to have the police package (lights, siren, etc.) installed. Two officers will be scheduled for their 80 hours of training at the end of August.
- Officer Ryan Falvey attended a Bike Rodeo and spoke with the youths about bicycle safety. This event is sponsored by the Christian Reformed Church on Goldthwaite Rd.
- All Dispatchers received a two (2) hour refresher course from the State 911 Department. This is a part of their annual 16 hours of mandatory training.
- Sgt. Ryan Levesque resigned from the department to pursue a career with the DEA (Drug Enforcement Agency). Sgt. Levesque served the department for 7 years.
- Officer Kaitlyn Laflash resigned from the department to pursue a career with the DEA (Drug Enforcement Agency). Officer Laflash served the department for 5 years.
- Dispatcher Jeffrey Mayer will be replacing one of the above vacancies upon completion of all the necessary pre-requisites to attend the police academy.

• Chief Labrie worked with Public Safety Consultants, LLC to set up an Entry Level Police Officer Exam. The exam will be held at the police department on 10/7/23. This will help create a list of candidates to pick from for the vacancy created by Officer Laflash and any future vacancies.
