## **ADDITIONAL INFORMATION:**

The police department received 1366 calls for service from 02/01/24 – 02/29/24. 27 Adults and Juveniles were either arrested or summoned into court for various charges to include: Assault & Battery on Family/ Household Member, B&E Nighttime for Felony, Leave Scene of a Property Damage Accident, Operating Under the Influence of Alcohol, Possess to Distribute Class A Drug and Unarmed Robbery. There were twenty seven (27) Motor Vehicle Accidents investigated, 2 of the accidents resulted in personal injury. 9 People were taken to the hospital for a Mental Health Evaluation. Officers responded to complaints that resulted in 30 Incident Reports being created for various crimes.

- Lt. Ouillette conducted uniform and equipment inspections for all police officers.
- Student Officer Jeffrey Mayer completed Emergency Vehicle Operation and Firearms Qualification while at the Boylston Academy. Student Officer Mayer is at the half way point of the 24 week academy.
- Chief Labrie attended two staff meetings hosted by TM Adam Gaudette. One was to discuss the future of the Northbridge Elementary School on Cross St. The conceptual proposal by Lobisser Building Corp. for the new construction of apartments buildings was excellent and clearly needed in our community. As Chief of Police, I have no objections to the proposal for apartments and the sale of the land to this company. The second meeting was to discuss the town budget and various department requests/needs.
- Chief Labrie and Lt. Ouillette attended a meeting with the all the command staff of the police departments that make up the Blackstone Valley Drug and Counter Crime Task Force.
- Chief Labrie met with Town Manager Adam Gaudette to discuss negotiations with the Dispatcher Union.
- Sgt. Tyler Mitchell is at Firearms Instructor Training. Upon completion, Sgt. Mitchell and Officer DeJordy will be the two Firearms Instructors.
- Part-Time Dispatcher David Nowlan completed “Law Enforcement Dispatch” and ‘Fire Service” as part of his 16 hours of Con-Ed training required by the State 911 Department.
- Sgt. White and Officer DerKosroffian attended annual In-Service Training sponsored by the Municipal Police Training Committee.
- Det. Sgt. Gorman led an extensive investigation into a juvenile runaway that involved several local, state, and federal agencies. The juvenile eventually turned herself in to a juvenile facility in Atlanta Georgia. SRO Tom DeJordy is working with MA and Georgia DCF’s to arrange for the juvenile to be returned to MA.
- Chief Labrie attended a WebEx meeting of the MA Chiefs of Police. Topic: Possible

changes to Civil Service and how the changes could affect both Civil Service and Non Civil Service Communities.

- SRO DeJordy attended a seminar on Juvenile Investigations sponsored by the Municipal Police Training Committee in Lynnfield, MA.
- Chief Labrie met with Town Manager Adam Gaudette to discuss negotiation strategies with the Dispatch union and the FY-25 police department budget.
- Chief Labrie presented Student Officer Christopher Dutting to the Board of Selectmen on 2/26/24. SO Dutting's appointment was affirmed by the BOS and he will be attending the police academy in May.
- Chief Labrie, Lt. Ouillette, Det. Sgt. Gorman, Sgt. Mitchell, Officer Ciccone, and Officer Marino attended the annual In-Service training sponsored by the Municipal Police Training Committee.
- Sgt. Mitchell attended Firearms Instructor training sponsored by the Municipal Police Training Committee.
