ADDITIONAL INFORMATION:

The police department received 1603 calls for service from 03/01/24 – 03/31/24. 22 Adults and Juveniles were either arrested or summoned into court for various charges to include: Assault & Battery on Family/ Household Member, Fail to Stop for Police, Illegal Dumping Trash from a Motor Vehicle, Improper Storage of a Firearm, Leave Scene of a Property Damage Accident, Operating Under the Influence of Alcohol 2nd offense Reckless Endangerment of a Child and Violation of Abuse Prevention Order,. There were forty two (42) Motor Vehicle Accidents investigated, 5 of the accidents resulted in personal injury. 7 People were taken to the hospital for a Mental Health Evaluation. Officers responded to complaints that resulted in 41 Incident Reports being created for various crimes.

- Det. Sgt. Gorman led an extensive investigation into a juvenile runaway that involved several local, state, and federal agencies. The juvenile eventually turned herself in to a juvenile facility in Atlanta Georgia. SRO Tom DeJordy is working with MA and Georgia DCF's to arrange for the juvenile to be returned to MA.
- Chief Labrie attended a WebEx meeting of the MA Chiefs of Police. Topic: Possible changes to Civil Service and how the changes could affect both Civil Service and Non-Civil Service Communities.
- SRO DeJordy attended a seminar on Juvenile Investigations sponsored by the Municipal Police Training Committee in Lynnfield, MA.
- Chief Labrie met with Town Manager Adam Gaudette to discuss negotiation strategies with the Dispatch union and the FY-25 police department budget.
- Chief Labrie presented Student Officer Christopher Dutting to the Board of Selectmen on 2/26/24. SO Dutting's appointment was affirmed by the BOS and he will be attending the police academy in May.
- Chief Labrie, Lt. Ouillette, Det. Sgt. Gorman, Sgt. Mitchell, Officer Ciccone, and Officer Marino attended the annual In-Service training sponsored by the Municipal Police Training Committee.
- Several officers responded to the large fire at 120 Hill St. The cause of the fire remains under investigation.
- Sgt. Mitchell attended Firearms Instructor training sponsored by the Municipal Police Training Committee.
- Chief Labrie and SRO DeJordy participated in the annual Dr. Seuss Day and read to the children at NES.
- SRO DeJordy attended a career fair at the Whitinsville Christian School.
- Student Officer Dutting passed his Physical Agility test for entrance into the Police Academy.
- Chief Labrie met with local business owner Randy Bloem of B2B Holdings, Inc.
- Chief Labrie attended the Finance Committee Meeting to discuss and answer questions concerning the FY-25 Police Department Budget, Budget Requests, and Line Items.
- Chief Labrie met with a local resident to discuss his Rhode Island License to Carry Firearms.

- Officers of the NPD Motor Unit provided a funeral escort with the CEMLEC Motor Unit.
