ADDITIONAL INFORMATION:

The police department received 1603 calls for service from 04/01/24 – 04/30/24. 20 Adults and Juveniles were either arrested or summoned into court for various charges to include: Assault & Battery with a Dangerous Weapon, Leave Scene of a Property Damage Accident, Operating Under the Influence of Alcohol, Possess to Distribute Class B Drug and Possession of Class A and B Drugs. There were twenty two (22) Motor Vehicle Accidents investigated, 5 of the accidents resulted in personal injury. 7 People were taken to the hospital for a Mental Health Evaluation. Officers responded to complaints that resulted in 39 Incident Reports being created for various crimes.

- Sgt. Mitchell attended a two-day Firearms Instructor Training sponsored by the MPTC-Municipal Police Training Committee.
- Sgt. Jeff White attended a training for Accident Reconstruction
- Chief Labrie attended a WebEx meeting sponsored by the MA Division of Labor Relations. Topic: Northbridge Police changing unions.
- NPD Motor Unit attended a ‘Touch a Truck’ event sponsored by the Shrewsbury police Department.
- Chief Labrie attended a department head meeting hosted by Town manager Adam Gaudette.
- Chief Labrie and Town Manager Adam Gaudette met with town council to discuss negotiations with the dispatch union.
- Chief Labrie worked with the Board of Health to coordinate the usage of the old NES for their active shooter training.
- SRO Tom DeJordy attended the “Spirt of Learning” event at Northbridge High School.
- All officers of the department attended active shooter training. Sgt. Mitchell and SRO DeJordy conducted the training. Officers worked on room entry and identifying armed suspects.
- Sgt. Mitchell worked at the Boston Marathon start line with the CEMLEC Swat team.
- SRO DeJordy and Officer Ryan Falvey worked at the Boston Marathon with the CEMLEC Motor Unit.
- Sgt. Patrinelli as part of the NPD Motor Unit and CEMLEC Motor Unit worked a large funeral in Worcester.
- Chief Labrie and Town Manager, Adam Gaudette met with the Dispatcher Union to initiate contract negotiations.
- Chief Labrie taught a law class for the Northbridge High School Law Program under the direction of Mr. Alan Finkel.
- Lt Ouillette took part in the Drug Enforcement Agency Prescription Drug Take Back Day.
- Sgt. Brian Patrinelli and Sgt. Tyler Mitchell attended a training seminar for Tactical Communication and Leadership.

- All Dispatcher and Officers attended annual CPR and First Responder Training.
