The police department received 1707 calls for service from 06/01/24 - 06/30/24. 20 Adults and Juveniles were either arrested or summoned into court for various charges to include: Assault & Battery on a Family/ Household Member, Fail to Register as a Sex Offender, Fail to Stop for Police, Owner Fail to Report Firearm Transfer/Loss, Strangulation and Vandalize Property. There were thirty five (35) Motor Vehicle Accidents investigated, 7 of the accidents resulted in personal injury. 6 People were taken to the hospital for a Mental Health Evaluation. Officers responded to complaints that resulted in 29 Incident Reports being created for various crimes.
