ADDITIONAL INFORMATION:

The police department received 1631 calls for service from 07/01/25 – 07/31/25. 28 Adults and Juveniles were either arrested or summoned into court for various charges to include: A&B Dangerous Weapon, Home Improvement Contractor Violation, Indecent Exposure, Larceny from Building, OUI-Liquor, Possess Firearm without a FID Card and Violate Abuse Prevention Order. There were Twenty Eight (28) Motor Vehicle Accidents investigated. 3 People were taken to the hospital for a Mental Health Evaluation. Officers responded to complaints that resulted in 50 Incident Reports being created for various crimes.

- SRO Tom DeJordy helped run the Northbridge/Uxbridge Youth Police Academy-30 youths from Uxbridge participated. There will be a second academy in Northbridge.
- Chief Labrie met with local and state officials to discuss and plan for the closure of the Mendon Rd. bridge on 7/25/25.
- Det. Sgt. Gorman assisted with the Entry Level Police Officer exam held at the police department on 7/12/25.
- Chief Labrie met with TM Adam Gaudette on various personnel/departments matters.
- Lt. Ouillette completed and received numerous grants from the State 911 Department.
- All-Comm continued to work the new department radio system.
- Chief Labrie received proposals for the upcoming Police Sergeant Exam process.
- The police department switched over to a new Digital Radio System as part of the town's upgrade funded by ARPA funds. All officers were issued brand new portable radios.
- Chief Labrie and Fire Chief White met with officials from Mendon Police and the Metacomet Dispatch Center to finalize response protocols during the Mendon Rd bridge closure.
- Members of Lifesong Church in Sutton volunteered to their time and money to paint the exterior of the police department resulting in a savings of approximately 10-15k to the Town of Northbridge. Upon completion there will be a photo op, and I will also ask the Town Manager to have these volunteers recognized at the BOS meeting in the future. We will pick a date that works for everyone.
- Several officers of the department worked traffic and crowd control for the annual fireworks on 7/19/25 under the direction of Lt. Ouillette. It was a successful/safe night with the hard work of the Police, Fire, and DPW Departments.
- Public Safety Consultants LLC was chosen to conduct the Police Sergeant Exam.

- Student Officer Jared Smith has two weeks left at the police academy.
- Student Officer John Ryan has completed 1/3 of the police academy.
