ADDITIONAL INFORMATION:

The police department received 1653 calls for service from 01/01/26 – 01/31/26. 19 Adults and Juveniles were either arrested or summoned into court for various charges to include: A&B on a Police Officer, Larceny Over \$1200 by False Pretense, OUI-Liquor, Shoplifting, Trafficking in 18 grams or more of Cocaine and Violation of Abuse Prevention Order. There were Twenty Eight (28) Motor Vehicle Accidents investigated. 6 People were taken to the hospital for a Mental Health Evaluation. Officers responded to complaints that resulted in 28 Incident Reports being created for various crimes.

- SRO DeJordy attended a school safety meeting for the Whitinsville Christian School.
- Chief Labrie prepared the police department budget for FY 27.
- Student Officers Clarke and Parker started the police academy in Lynnfield.
- Chief Labrie attended a pre-construction meeting for the Quaker St. water main project.
- Officer DerKosrofian met with Verizon reps concerning cell phones and business phones in the department.
- Officers Benjamin O'Donnell and Brian Carroll participated the Sergeant Promotional Exam process.
- Officers Brian Carroll and Christopher Dutting attended Field Training Officer training.
- Chief Labrie taught a law class for Northbridge School students under the direction of Alan Finkel.
- The Northbridge Police Department supported the Uxbridge Police Department with their tragic loss of Officer Stephen A. Laporta. Under the direction of Lt. Ouillette, officers worked shifts for the grieving members of the Uxbridge Police Department, and several Northbridge officers attended the wake and funeral services of Officer Laporta. Sgt. Patrinelli and Officer DeJordy assisted the CEMLEC Motor Unit with the escort of Officer Laporta. Please keep Officer Laporta and his family in your thoughts and prayers!
- Sgt. Mitchell attended SWAT Training and assisted various towns with the execution of warrants.
- Det. Sgt. Gorman and Sgt. Mitchell conducted an annual audit of the police department evidence room.
- Officer DerKosrofian met with representatives from Verizon to discuss phone upgrades and fiber connection.
- Chief Labrie conducted interviews with the two candidates for the open Sergeant position. As a result of the entire process Officer Brian Carroll will be promoted to the rank of Sergeant effective 2/8/26.
